Notice for opportunity of personal hearing

It is stated that show cause notices were issued to holders of illegally clubbed permits as mentioned in the table below. In pursuance to these show cause notices these operators were given an opportunity of personal hearing on 21.10.2024 which was duly availed by them but they failed to furnish their reply to these show cause notices. Subsequently, after the judgment dated 21.01.2025 rendered by the Hon'ble High Court of Punjab and Haryana in CWP 20651 of 2024 titled as M/S Jalal Bus Service Regd. Bathinda and connected cases, they filed their respective replies.

Therefore, in compliance of the above order of Hon'ble High Court, these operators are hereby given a last opportunity of personal hearing in the show cause notices served to them as mentioned against each for de-clubbing their permits and to restore their stage carriage permits on original status after extension, curtailment, increase in trips. The personal hearing shall be held by the undersigned in his office on 16.04.2025 at 10.30 A.M. in the interest of justice.
