- The bidder must submit the valid authorization by the Pollution Control Board as under:-
 - Hazardous waste eg. batteries/used oil (management & handling)rules,1989 as amended from time to time.
 - The bidder should be registered with ministry of Environment & Forests, & should possess valid actual user certificate.
- Material lots can be inspected on any working day at Ministers Car Section, Punjab, Plot No. 30-31, Industrial Area Phase-II, Chandigarh.
- Each lot of material in the Minister Car Section, Plot No. 30-31 Industrial Area Phase-II Chandigarh will be sold on "as is where is" condition/basis.
- Bidder may bid for single/multiple lots in the sheet provided on MSTC portal by paying EMD/security amount accordingly.
- Material lots will be sold to highest bidder & will be allowed to pick the lots after full payment & GST (@bid price & after completion of all other relevant charges & affidavit/documentation within 72 hours after his bid has been accepted (after excluding the holidays ,if any). In case the highest bidder does not lift the lot of material within the stipulated time the earnest/security money will be forfeited.

9. The loading/unloading/weigh bridge charges and any other relevant charges are to be borne by the bidder/purchaser.
10. The material lot will be delivered to tenderer only & the documentation will be prepared on the name of tenderer only.
11. State Transport Commissioner, Punjab will have the right to accept or reject any of the tender.
12. If tenderer have any dispute with department, in that case State Transport Commissioner, Pb will refer case to Additional State Transport Commissioner or any other officer. The decision of this officer shall be acceptable to both parties.
13. State Transport Commissioner will have the right to keep/ withdraw any of the sold lots after publication of tender or after opening of tender.
14. The court at Chandigarh only shall have the jurisdiction for the purpose of any court case.
