Terms & Conditions to be uploaded on website:-

- 1 Vehicles can be inspected on any working day at Ministers Car Section, Punjab, Plot No. 30-31, Industrial Area Phase-II, Chandigarh.
- 2 Each vehicle in the Minister Car Section, Plot No. 30-31 Industrial Area Phase-II Chandigarh will be sold on “as is where is” condition/basis.
- 3 Bidder may bid for single/multiple cars in the sheet provided on MSTC portal by paying EMD amount accordingly.
- 4 Vehicle will be sold to highest bidder & will be allowed to pick the vehicle after full payment & 18% GST (@bid price), & after completion of all other relevant charges & affidavit/documentation within 72 hours after his bid has been accepted (after excluding the holidays ,if any). In case the highest bidder does not lift the vehicle within the stipulated time the earnest money will be forfeited.
- 5 EMD and full amount for cars of (STC, PB & PB and Haryana High Court) auctioned through MSTC are to be deposited online in following account:

- 6 Demand drafts for 18% GST calculated at the bid price of vehicle by the tenderer are to be made in the name of ‘THE BANK MANAGER, STATE BANK OF INDIA’ payable at Chandigarh.
- 7 The RC transfer fees/charges/insurance and any other relevant charges to be borne by the bidder/purchaser.
- 8 The tenderer has to furnish an affidavit duly notarized that in case the bidder does, not gets the RC transferred on his name within stipulated time the department reserves the right to cancel the RC from the respective RTO.
- 9 The vehicle will be delivered to tenderer only & the transfer papers will be prepared on the name of tenderer only.
- 10 State Transport Commissioner, Punjab shall have the right to accept or reject any of the tender.
- 11 If tenderer have any dispute with department, in that case State Transport Commissioner, Pb will refer case to Additional State Transport Commissioner or any other officer. The decision of this officer shall be acceptable to both parties.
- 12 The registration number of Punjab & Haryana High Court vehicles will be retained by the department and the respective department will provide the transfer documentation of their vehicles to the successful bidders.
- 13 State Transport Commissioner shall have the right to keep/ withdraw any of the sold vehicles after publication of tender or after opening of tender.
- 14 The court at Chandigarh only shall have the jurisdiction for the purpose of any court case.
- 15 The vehicle which shall remain unsold through auction on MSTC portal on 21/10/21 will be sold at the reserve price on “ FIRST COME FIRST SERVE” basis to the following mentioned categories Govt. Employees, retired Govt. Employees, Ex MPs, EX MLAs, War Widows, MPs and MLAs. All these categories will have the same level of priority.
