No. 10/51/2011-1T2/ 1467 In exercise of the powers conferred under Subrule (2) of Rule 15 of the Central Motor Vehicles Rules, 1989, the Governor of Punjab is pleased to authorize all the Registrars of Universities and Principals of the Colleges/Institutes, affiliated to the Universities, approved by the University Grants Commission for conducting the competency test of their students only to drive non transport vehicles. For this purpose, Instructors who have the following qualifications can be hired from within or outside the college /Universities.

- i) having good moral character;
- a minimum educational qualification of a pass in the 10th standard;
- iii) a minimum driving experience of five years in addition to a certificate in a course in motor mechanic or any other higher qualification in mechanical engineering from an institution established by the central or state government or from an institution recognized by the Board of Technical Education of a State Government.
 - iv) thorough knowledge of traffic signs specified in the Schedule to the Act and the regulations made under section 118.
 - v) ability to demonstrate and to explain the functions of different components, parts of the vehicles.
 - vi) adequate knowledge of English and the Punjabi language.

To authorize all the Registrars of Universities and Principals of the Colleges/Institutes, affiliated to the Universities, approved by the University Grants Commission for conducting the competency test of their students only to drive non transport vehicles - guidelines thereof.

The State Govt. has authorized all the Registrar of Universities and Principals of the Colleges/Institutes, affiliated to the Universities, approved by the University Grants Commission for conducting the competency test of their students only to drive non transport vehicles under Rule 15 of the Central Motor Yehicles Rules, 1989 vide Notification No. 10/51/2011-1T2/ dated, July 2011. With a view to follow the procedure for the purpose, the following guidelines are to be adhered to:-

- 1) The provisions of Motor Vehicles Act, 1988, Rule 15 of the Central Motor Vehicles, Rules, 1989, the provisions of Punjab Motor Vehicles Rules, 1989 and Instructions Issued under the Motor Vehicles Act/Rules are to be followed meticulously.
- Receipt Books for collection of government fee for Competency Test to drive and Registers for maintenance of record shall be obtained/supplied by the concerned District Transport Officer/Sub Divisional Magistrate. The record shall be maintained in these registers properly and shall be produced for inspection/audit before the competent authority.
- The prescribed government fee under Rule 32 of the Central Motor Vehicles Rules, 1989 is to be charged by issuing receipts, so obtained from the office of the District Transport Officer/Sub Divisional Magistrates and deposit it into the government treasury, under the Head of Motor Vehicles Department "0041-Taxes on Vehicles 102 Receipt under Motor Vehicles Tax Act 01 Tax Receipts".
- 4) Every applicant for the test of competency to drive the vehicles mentioned in the application form No. 4 shall produce/appear himself before the authority along with a serviceable vehicle of the class to which the application belongs for testing purposes. The competency test shall be conducted as per the provisions of Rule 15 of the CMV Rules, 1989.
 - Where the applicant does not pass the test he will be permitted to reappear for the test after a period of seven days as specified under Subsection 5 of Section 9 of the Motor Vehicles Act, 1988. Where the applicant does not pass the test even after three appearances, he shall not be permitted to appear for such test before the expiry of 60 days from the date of last such test. The testing officer is required to mention the details of the deficiency found in the competency test on the application of the applicant.
- When the applicant passes the competency test to drive the motor vehicle, mentioned in the application, subject to the provisions of Section 9 of the Motor Vehicles Act, 1988, the authority is required to indicate the passing of the competency test on the application of the successful applicant. Thereafter, the application of such applicant will be forwarded to the licensing authority concerned for issue of driving license.

- 7) Periodical statements shall be submitted to the office of the District Transport Officers/Sub Divisional Magistrates except district headquarters under intimation to the State Transport Commissioner, Punjab.
- 8) Any information sought by the Transport Department shall be supplied within the prescribed time.

In case of any Irregularity and violation of the provisions of Motor Vehicles Act, 1988, the Central Motor Vehicles Rules, 1989 and the Punjab Motor Vehicles Rules, 1989 and Instructions issued under the Act/Rules, action under the law is liable to be taken.

9) Apart from the prescribed government fee under Rule 32 of Central Motor Vehicles Rules, 1989, there will be a collection of Rs. 80 per application as user charges, out of which Rs. 60 can be retained by the concerned Institute/College/University and Rs. 20 will be passed on to the Transport Department through District Transport Officer/Sub Divisional Magistrate.
