No. 10/51/2017-1T2/1163 In partial amendment of notification No 10/51/2017-1T2/1375733/1 dated 17.12.2018 and in exercise of powers conferred by Rule 42-A of the Punjab Motor Vehicles Rules, 1989 and all other powers enabling him in this behalf, the Governor of Punjab is pleased to amend the terms and conditions as specified below:

The process of e-auction shall be as under:

1. For participation in the bidding/auction, the bidder will have to register himself/herself on the website, and obtain his Unique Acknowledgement Number (UAN).

2. The registration window shall be open from 9:00 am on every Sunday till Tuesday (12:00 midnight), the bidding will take place from Wednesday (12:01 AM) till Thursday(12:00 midnight) and the payment period for successful bidder will be from Friday(12:01 AM) till Saturday(12:00 midnight) on the online e-auction platform. This facility will be available on Gazetted holidays also.

Registration: Sunday (9:00 AM) to Tuesday (12:00 midnight) (Day 1, Day 2 & Day 3)
Bidding : Wednesday(12:01 AM) to Thursday(12:00 midnight)(Day 4 & Day 5)
Payment by successful bidder : Friday (12:01 AM) till Saturday (12:00 midnight)(Day 6 & Day 7)

3. All reserved numbers of active series will be available for bidding through e- Auction.
4. The State Transport Commissioner, Punjab can also make available un-allotted reserved numbers of previous closed series through e-auction, but not less than reserve price.
5. Next new series can be activated if all the non reserved number of current series get assigned.
6. The information related to registration and the necessary details like login ID, password etc for bidding shall be sent to the registered mobile number or e-mail or both given at the time of registration by the bidders.
7. The e-auction participation charges will be Rs.1000/-per number. The charges shall be deposited by the owner online, for participating in e-auction, which shall be non-refundable.
8. The reserved number shall be allotted to the highest successful bidder. The Bids shall be made in the multiple of Rs. 500 only.
9. The bidding will start from reserve price of the reserved number. The reserve price will be displayed against each reserved number on the e-auction portal.
10. With the end of the bidding time, the name of successful bidder shall be flashed on the portal. The successful bidder may also be informed through SMS or email. To ensure transparency of bidding process, the results of successful as well as unsuccessful bidders shall be published on the website www.parivahan.gov.in.
11. The allotment letter of reserved number will be generated online when the successful bidder deposits his bid amount online within the stipulated time. *(No need to visit any office)*
12. The allotment to the successful bidder, shall be non-transferable and shall be used for the vehicle owned by the successful bidder only.
13. If the successful bidder fails to deposit the bid amount within two days from the date of closure of bid, the allotment of notified reserved number shall stand cancelled and shall be available for further e-auction.
14. Any reserved number that remains un-auctioned after undergoing the first auction process shall be designated as 'unassigned reserved number' and shall be available for further e-auction.

15. The allotment of reserved numbers shall be valid for 15 days from the date of issue of the allotment letter. If the vehicle owner does not register his vehicle within 15 days, the allotment of the reserved number shall automatically stand cancelled and the amount deposited will be forfeited and no refund shall be given. The allotted reserved number will be released and available to public in further e auction.
16. If a successful bidder makes payment within the period of 2 days(as per clause 2) and the full amount of a reserved number is deducted from his/her bank account, but transaction is pending at any level, in that case there will be a buffer period of 7 days for a successful bidder to get the payment cleared. If the payment of the reserved number is not cleared in 7 days buffer period, than the reserved number shall be released and available for next e-auction.
17. Press release/Advertisement shall be issued quarterly for general awareness of the public.
18. In case of any dispute, the State Transport Commissioner will decide the matter.
19. If the bidders are not satisfied with the decision of the State Transport Commissioner, Punjab (as per clause 18) they may file an appeal to the Principal Secretary, Transport within 21 days of decision made by the State Transport Commissioner. The decision made by the Principal Secretary, Transport shall be final in this case.
20. The State Transport Commissioner, Punjab reserves the right to postpone or reschedule e-Auction process at any stage.
21. The Principal Secretary, Transport reserves the right to cancel e-Auction process at any stage.
