In order to regulate the operation of stage carriages (buses) having the minimum and maximum seating capacity of 24 and 35 seats including driver and conductor respectively in the rural areas in the interest of travelling public as well as to avoid unhealthy competition amongst the stage carriage operators, the Governor of Punjab, in exercise of the powers conferred by Section 68 (3) (ca) of Chapter V of the Motor Vehicles Act, 1988 read with clause 3E of the Punjab Transport Scheme dated 22.02.2018 as modified on 04.06.2019, is pleased to formulate the following routes falling within the jurisdiction of respective Regional Transport Authority of Hoshiarpur-
